### **Minutes of a Meeting of the Allotment & Open Spaces Committee held on Wednesday 13<sup>th</sup> August at 7.30pm in the Wren Room at St Mark's Church and Community Centre, Calder Rise, Brickhill, Bedford.**

2.	<b>Declarations of Interest in items on the agenda:</b>  None.	
3.	<b>Public Open Sessions (10 minutes):</b>  A tenant asked about closure of the allotments as reported in national newspapers by Borough Councils and asked if we are under any threat of this. Cllr Fitzpatrick responded that Brickhill Allotments belong to and are funded by the Parish Council, and we have no intention to do anything to reduce the allotment area. Cllr Fitzpatrick stated that we do not breakeven and the only way to achieve this is to increase rent dramatically.  The 3 year plan – Assistant Clerk has received emails from tenants with their suggestions.	



	<p>A tenant asked if we could put on a produce show and Cllr Fitzpatrick replied we have a Brickhill Parish Newsletter that could advertise this event.</p> <p>A tenant asked if he could set up a designated area for burning, in the northwest corner of the allotments away from the houses. Cllr Fitzpatrick replied using plinths of this site is acceptable.</p> <p>A tenant said to take allotment rubbish to the tidy tip you must have a permit and sign to say the rubbish taken is from your house. Cllr Fitzpatrick said we need to take this point up with the Borough as people with allotments should be able to take rubbish there.</p> <p>A tenant said the bolt on the northeast gate is difficult to open. Assistant Clerk to get fixed.</p> <p>Cllr Grant stated that the funding from the Parish Council has been agreed, and the allotments to be part of the neighbourhood plan and have been put in front of an inspector. Once signed and agreed this will give us more protection for local food growing sites.</p>	Assistant Clerk
